- The following categories of dogs may be entered and shown in Best of Breed competition; Dogs that are Champion of Record and dogs which, according to owner's records, have completed the requirements for a championship; championships are unconfirmed. The showing of unconfirmed Champion of Breed competition is limited to a period of 90 days from the date of the dog completed the requirements for a championship.
